# **AEA Membership to Vote on Board of Directors During Election This Week at Convention**

Voting takes place from Tuesday, April 22 to Thursday, April 24, during the annual AEA International Convention & Trade Show at the Gaylord National Resort in Washington, D.C.

There are six open director positions for this year's election. Pursuant to AEA bylaws, each AEA member company has one vote per company. Election results will be announced during the AEA Annual Awards Luncheon on Friday, April 25.

Current AEA Board Members seeking re-election are:

#### MATT FOWLE, General Manager, Mid-Continent Instruments West, Van Nuys, Calif.

Matt Fowle holds a degree in electronics engineering. Since 1991, he has been the general manager of Mid-Continent Instruments' West Coast facility, where he is responsible for all aspects of the operation.
