- Practical training of EWIS lays the groundwork for safe and efficient maintenance, alteration, and repair of EWIS in airplanes. This course offers hands-on training which emphasises the proper use of tools when performing repair as well as replacement of connective devices. After the course, participants have acquired the skills to demonstrate assembly and repair of harness and replacement of different connectors in aircraft. The instructor takes existing skills and competencies into consideration to provide individual guidance during the course.

2-day Auditor Training

- All aviation professionals must adopt a mindset of safety and compliance according to defined standards. Monitoring that these standards are followed is a discipline known as compliance monitoring – or conducting audits. This job is assigned to auditors. Being an auditor requires intricate knowledge of standards and regulations for products, services, and processes. But one thing is doing the job. Another thing is knowing why it is important to conduct quality control and ensure conformity to regulations. Our auditor training enables auditors to work with objective evidence through observations and interviews, particularly in the areas of SMS, quality control, and the supply chain relations.

This course revolves around the proactive search and review of legislation relevant to the area of responsibility, including familiarity with the responsibility that comes with initial and recurring airworthiness. The aim is to obtain general knowledge of safety activities to get the proper approval from national authorities to function as a Nominated Person – and designated deputies within EASA’s Continuing Airworthiness. Accountable Managers will benefit from the training as well.

After completing the course, the participants will be aware of the reason for introducing the FTS and EWIS concepts. This includes the common problems that may be encountered when working on these systems and how and where to obtain and use maintenance data relevant for work on these systems.
